

## **REGISTRATION TERMS & CONDITIONS**

The following Terms and Conditions (the “Terms and Conditions”) govern your purchase and attendance for the Event (as defined herein). You understand and agree that this is a public event, that your appearance and actions inside and outside the Event are public in nature, and that you have no expectation of privacy with regard to your action or conduct associated with the Event. You understand that there are safety protocols in place for the Event and you confirm that you will follow all applicable protocols and procedures.

Event registration (“Registration”) is valid for entry access for one (1) attendee (“you”) to Psychedelic Science 2025 Conference (“Event”) produced by the Multidisciplinary Association for Psychedelic Studies through its affiliate, Psychedelic Science Events LLC (collectively, “MAPS”) for the date(s), time(s), and location(s) listed on your Registration. No guests are allowed inside the Event site without their own valid Registration. Entry access to any additional or add-on experiences is governed by the additional entry access terms associated with the Registration type purchased.

You agree to abide by all health, security, and safety requirements and all instructions provided by MAPS representatives and/or Event staff, CDC guidelines, Event venue policies, and the requirements or recommendations of federal, state, and/or local health officials. Health and safety rules and instructions are subject to change at any time in MAPS’s sole discretion and/or in accordance with CDC guidelines, Event venue policies, and the requirements or recommendations of federal, state, and/or local health officials. MAPS and their representatives reserve the right to revoke your license granted by the Registration, seize Registration, refuse admission and/or remove guest(s) from Event for, without limitation, violation of these Terms and Conditions, failure to comply with prohibitions on recording and photography based on onsite event and property signage, harassing or offensive conduct, use of vulgar or abusive language, failure to comply with the directions or instructions of MAPS’s representatives, failure to submit to required health screenings, biometric scans, or searches, or for any other reason whatsoever, as determined in MAPS’s sole discretion.

The Event may be filmed and photographed by MAPS and other parties. You waive any ownership or publication rights with respect to the Recordings, and shall have no right of approval, no claim to compensation, and no claim whatsoever (including, without limitation, claims based upon invasion of privacy, defamation, libel, slander, false light or right of publicity) arising out of any use, blurring, alteration, distortion, illusionary effect, faulty reproduction, or use in any composite form of your Likeness as specified herein. You also waive any and all right to payment or other compensation arising from or related to Recordings.

You acknowledge and understand that you are attending the Event at your own risk. Attendance at the Event could involve bodily injury and property loss. AS LAWFUL CONSIDERATION FOR BEING PERMITTED ACCESS TO THE EVENT, YOU ASSUME FULL RESPONSIBILITY FOR ANY INJURIES OR DAMAGES THAT MAY OCCUR TO YOU IN, ON, OR ABOUT THE EVENT AND ITS PREMISES AND FULLY AND FOREVER RELEASE AND DISCHARGE THE RELEASED PARTIES (DEFINED BELOW) FROM ANY AND ALL CLAIMS, DEMANDS, DAMAGES, RIGHTS OF ACTION, OR CAUSES OF ACTION, IN CONNECTION WITH, RESULTING FROM OR ARISING OUT OF THE EVENT, INCLUDING, WITHOUT LIMITATION, TO YOUR ATTENDANCE. This release extends and applies to all unknown, unforeseen, unanticipated, and unsuspected injuries, damages, loss, and liability, and the consequences of them, as well as those disclosed or known to exist. Released Parties assume no responsibility and shall have no liability (including for negligence) for any such Claims, (INCLUDING, WITHOUT LIMITATION, FOR PERSONAL INJURIES OR WRONGFUL DEATH) THAT MAY ARISE IN CONNECTION WITH, OR RELATE IN ANY WAY TO, EXPOSURE TO OR CONTRACTION OF A COMMUNICABLE AND/OR INFECTIOUS DISEASE,, DURING PARTICIPATION IN THE EVENT, INCLUDING, WITHOUT LIMITATION, THOSE CLAIMS THAT ARISE AS A RESULT OF: (I) THE NEGLIGENCE OF ANY OF THE RELEASED PARTIES, AND/OR (II) THE INHERENT RISKS ASSOCIATED WITH ATTENDING THE EVENT DURING ANY EPIDEMIC OR PANDEMIC. ATTENDEES FURTHER AGREE THAT THE FOREGOING RELEASE OF LIABILITY AND COVENANT NOT TO SUE EXTENDS TO AND ENCOMPASSES ANY AND ALL CLAIMS, LIABILITIES OR DEMANDS THAT RELATE IN ANY WAY TO EXPOSURE TO OR CONTRACTION OF A COMMUNICABLE OR INFECTIOUS DISEASE,, BY ANY OTHER INDIVIDUAL, INCLUDING, WITHOUT LIMITATION, THEIR MINOR CHILDREN AND/OR FAMILY MEMBERS, AS A RESULT OF ATTENDING THE EVENT OR AS A RESULT OF THEM BEING EXPOSED TO SUCH DISEASES BY AN ATTENDEE AFTER SUCH ATTENDEE’S PARTICIPATION IN THE EVENT, TO THE EXTENT PERMITTED BY LAW.

#### CANCELLATION POLICY

All sales are final, no refunds. If the Event is canceled, you will have a thirty (30) calendar day refund window from the cancellation announcement to decide if you would like a refund or for your Registration(s) to rollover to future Event dates. If new Event dates are not announced, if you are unable to attend on the new dates, or you would prefer to receive a refund, you must submit your request to [registration@psychedelicscience.org](mailto:registration@psychedelicscience.org) within the thirty (30) calendar day refund window. If you do not request a refund during the thirty (30) calendar day refund window, your Registration(s) will automatically rollover to rescheduled dates. Cancellation with full refund will be issued if canceled prior to June 1, 2025. Cancellations past this date are based on circumstance and will be considered on a case by case basis.

Event dates/times are subject to change, delay and cancellation with or without notice including for capacity, weather, and force majeure. Event details (including, without limitation, details of additional or add-on experiences) are subject to change or cancellation with or without notice. Event programming is subject to change. Unfortunately, we cannot extend credits or refunds on cancellations requested due to programming changes.

#### MEDIA POLICY
